I was born in Panama, attended a Catholic Private School, moved to New York in 1967 to finish my senioryear at a public school in Brooklyn, New York. My senior year was a challenge, but thanks to my athletic skills, I was able to join the Tennis and Volleyball Teams, and the English language was no longer an obstacle!!

I arrived in Corpus Christi in 1970, right after Hurricane Celia, and welcomed by very friendly students and faculty at the University of Corpus Christi (UCC). After graduation, I spent about a year trying to figure out what to do. Well, KEDT ended up being the only job in my professional career where I just recently celebrated my 47th Anniversary!

I became president of the EWI Chapter in 1996 and served on the EWI Corporate Board in 1998. Joining EWI was the best thing that happened in my professional career. I thank our EWI Corpus Christi Chapter, for the leadership skills and networking opportunities I acquired through my 24 years with the Chapter and I also thank EWI Corporate, for the many resources they made available to me, through their Annual Meetings, Regional Meetings, and Professional Webinars, to keep expanding those skills.
