Gracie emailed the report. The local website has been updated with the 30 year announcement and new members.

The January 9, 2013 Board Meeting Minutes were accepted.

Christine emailed the Treasurer's Report. The cash position at the end of January is as follows:

Checking account \$31,947.41; CD \$14,000.00; Business Development Program \$1,959.43; Total of \$47,906.84. Jackie made a motion to accept the financials statements as presented, and Linda seconded the motion. Per Christine's email, she will still be collecting for the Anniversary Dinner, Casino Night, and dues. Not all of the expenses for these three events have been posted yet; therefore, the January financials are somewhat misleading. All of the income and expense items from these events should be posted by the end of February.

Elaine presented the President's Report. Elaine brought the pens and post it notes from Marlins. The flash drives, membership pins, and blue file folios were ordered on January 18th. She does not know when they will be delivered. The Past Presidents council is working on the new member mentorship program. Myra Lombardo is in charge and has asked her committee for their input by February 8th. Once Jackie and her membership orientation committee receives the input, they will know how to proceed with new members. Elaine hopes to have their information on how they will handle the program by February 20th. Elaine hopes this will include that Jackie's committee will hand out the materials, member directory, committees and description of each committee to each new member. Elaine also has requested that each committee give a minimum of 1 paragraph of what the committee does by the next Board meeting.

Elaine stated that the President's Anniversary Dinner was very nice.

Mary Helen, Jackie McClain, and Susan Hutchinson did a wonderful job. She is looking forward to tonight's Casino Night Event. Linda presented the Vice President's Report. She has received all of the lists from Ellen Scott, and she has assigned them to committees. She will send out the completed lists.

In January, 61 RSVP'd and 59 attended.

Norma stated that there will be approximately 111 in attendance tonight. There is enough food for 125 people. The committee is pretty much ready for the event. They are still setting up the items and some other things. They have stayed in budget for the food. The profit per ticket is approximately \$10. She expects that Casino Night will make money.

Rebecca emailed her report. The report states that our May 8th program will be by the following from the Garcia Center about Arts and Education in our city: Linda Rodriguez, Curator of Education, Art Museum of South Texas; Dr. Gilda Ramirez, Director of the Antonio E. Garcia Arts & Education Center; and Bea Hanson, Director of the Food Bank of Corpus Christi.



Ellen Scott emailed her report. The report states that the membership process and delineated procedures for the billing of new members is not ready at Corporate yet. The old process of billing is still in effect. Christine will bill new members. We have 6 new members: Dr. Annette Garza from Amazing Results Chiropractic & Wellness, Terri Casler and Ashley Alexander from Trinity Towers (existing member firm, new representatives), Karen Barnes as a 2nd Rep from JK Jordan, Bridget Rusche as a 2nd Rep from Anita Garrett Roe Designs. One member will be dropped, and another member will possibly be dropped for nonpayment. Currently, there are a total of 63 members. A possible new member is Sheila Rollins from Rodan & Fields Dermatologists.

Jackie emailed her report. She has some ideas for seating to go with the candy idea. She would send out a welcome email to new members advising that they will be contacted by their mentor. The exact processes will be put into place once they get the final itemized list and processes from the Past President's committee.

Michelle emailed her report. Tina Vasquez from the Caller Times stated that the 2nd calendar item ran in the Hola Society calendar on Sunday and it ran in the business datebook. The photos of your organization submitted from the gala will also run in a future society section. Tina also asked Michelle that she submit photos to her for the comm page or to Sarah Tinsdall for the Hola society page when EWI has events that the Caller Times does not cover.
